Chair Collins called the open session meeting to order at 9:00 a.m. and a quorum was noted. She asked for a motion to approve the agenda; Trustee Wernecke made a motion; Trustee Harmon made a second; and the agenda was unanimously approved.

The first discussion item was an update on potential trustee vacancies with five anticipated for the 2025 academic year. This included Carlos Alcazar; Lex Birney; Peg Duchesne; Gail Harmon; and Sven Holmes. Chair Collins said they have candidates to fill all five positions and they will bring needed skills and diversity to the Board. The slate of new candidates will be put forth in October for a vote to enable the Governor's Appointments Office sufficient time to review the nominations and begin the process prescribed by law prior to the 2025 academic year. Chair Collins noted that in the bylaws, biographies for each candidate must be provided to the Board 30 days prior to consideration for approval and that she would be calling a meeting of the Governance Committee in September so that the Committee's recommendations could be forwarded to the Board as required.

The next item was the Board Survey, which does not require a formal action, but which the Committee endorsed at the meeting. Chair Collins noted that the survey would be presented to Board for its endorsement and that it would be sent to Board members in May with the expectation that the results would be reviewed at the Board of Trustees retreat. This survey will be conducted on a regular basis moving forward and the content will change accordingly, as needed.

Chair Collins then brought forth Action Item III.A. Approval of the Board of Trustees Calendar. The first two years (calendar years 2024 and 2025) were previously approved; only the third year

(2026) is new. Chair Collins asked for a motion to approve. Trustee Bryan made a motion; Trustee Harmon made a second; and the action item was unanimously approved. This concluded the open session of the meeting.

Chair Collins made a motion to go into closed session, in accordance with Maryland General Provisions Code Ann. § 3-305 (b) to review and discuss items permitted in closed sessions, specifically (1)(i) The appointment, employment, compensation, removal, resignation, or performance evaluation of appointees, employees, or officials over which it has jurisdiction; (2) To protect the privacy or reputation of individuals with respect to a matter not related to public business. Specifically, this was to review and vote on candidates for Board leadership positions and to discuss and vote on a candidate nominated for the Ark and Dove Award. The Committee would not go back into open session.

Chair Collins made a motion to move into closed session at 9:04 a.m. Trustee Wernecke made a motion; Trustee Bryan made a second. The motion passed unanimously.
